Commissioner Heacock let us know that Kitsap County DCD Director Rafe Wysham is unable to attend the meeting due to a family commitment. He will be attending our July All Ports meeting. He let us know that there have been major changes and improvements to the permit processing for the County, and that in the future Shoreline/Environmental/Land use and Stormwater reviews will all be done at one time. Some of these changes have been brought about because of senate Bill 5290

POULSBO

City has started patrolling Poulsbo Harbor, they have 4 new boat operators and are working on the derelict boat problem.

RBAW(Recreational Boaters Association of Washington) Pump out Services moor their boat in Poulsbo, will go to local areas to pump out moored vessel. (pumpoutnav.org)

E & F dock electrical has been repaired

Fuel dock is open now

Jay Lawrence has been designated as the person doing hiring and dismissal of employees

City of Poulsbo to limit Parking to 2 hour limit, then will become paid parking in the future

SILVERDALE

Working on permits for tenant improvements.

ILLAHEE

24 years to get project going, starting construction, had to move tenant from house, will be starting as soon as the natural gas line is removed.
