Port of Silverdale Regular Meeting Minutes

August 21st, 2025

The meeting was held in person at the Port of Silverdale office.

CALL TO ORDER

Commission Chair Ed Scholfield called the meeting to order at 6:00pm, others attending in person were Commissioner Rick Slate; Katie Byrd(administrator); Marvel Hunt; Carla Larson; Elizabeth Hamre; Brent Hamre; Patti Miele; Mary Kunish

Commissioner Reese was excused from this meeting.

The following Consent Agenda items were approved:

Elizabeth Hamre - 9004 Washington, Property Maintenance

Elizabeth Hamre of Elizabeth's House of Wax attended the Port meeting to discuss concerns regarding the general maintenance of the Port's rental properties and to confirm a move-in date for her new location at 9004 Washington.

Elizabeth noted that the roofs of several rental properties have not been cleaned in over two years and that the exterior of the buildings appears dirty and in need of a soft wash. She specifically mentioned 9004 Washington, 9020 Washington, and 3295 NW Lowell. Commissioner Scholfield stated that he would ask Ken Storm to address the roof cleaning, while Commissioner Slate will look into hiring someone to handle the soft washing of the buildings.

Commissioner Scholfield also informed Elizabeth that permitting for 9004 Washington has been officially completed, allowing her to begin moving items into the building and preparing for opening. He advised her to start the process of obtaining an occupancy permit, which is required before she can officially open. Commissioner Slate added that the window replacements included in the original scope of work are already underway. Clayton has hired a contractor and paid the deposit, with installation expected to be completed within the next month.

Elizabeth also raised concerns about a damaged post that has remained unrepaired for an extended period. She stressed that the post poses a potential safety hazard. The commissioners agreed to explore options for addressing the issue, including the possibility of having Tim with Tikar cut the post down and paint it yellow to reduce the risk. No final decision was made at this time.

Parking at 9004 Washington was another concern Elizabeth brought forward. She explained that parking in Old Town Silverdale is already very limited and that her building has an insufficient number of designated spaces. She suggested paving the adjacent dirt lot to create additional reliable parking for her clients, while also improving the appearance of the property. Elizabeth emphasized her loyalty as a tenant of over a decade and noted that delays in moving into 9004 Washington have caused her significant stress and unexpected challenges. Although her request to pave the lot has been denied in the past, she asked the commissioners to reconsider. Both Commissioner Scholfield and Commissioner Slate expressed understanding of her concerns. Commissioner Scholfield explained that his hesitation in the past stemmed from the permitting process for such improvements, which could make paving costly. However, he and Commissioner Slate acknowledged Elizabeth's patience and long-term commitment to the Port and agreed that they want to support her business's success. Commissioner Scholfield proposed that the Port investigate the paving process further and, if the project can be completed for under \$15,000, move forward with the request.

The commissioners will be scheduling a building walkthrough this month to identify remaining tasks. Carla Larson and Marvel Hunt requested to be present during this walkthrough.

Commissioner Slate made a motion to pave the parking lot at 9004 Washington as long as the cost does not exceed \$15,000.00. Commissioner Scholfield seconded the motion. Passed.

PUBLIC INPUT

Marvel Hunt - Whaling Days Concerns

Marvel expressed concerns about the volume of the music during Whaling Days. She explained that the music was loud throughout the day and into the evening, even inside her home. She also noted that sound checks began very early in the mornings, leaving residents in the area with no peace for three days.

Mary Kunish, representing the Art Studio, shared her frustration that Whaling Days staff began occupying and blocking all of the parking spaces at their rental as early as Wednesday morning. This created difficulties for both staff and clients. She added that many Old Town Silverdale businesses already experience loss of business during the Whaling Days weekend and that it is unfair for those impacts to begin spilling into the days prior to the event.

Carla Larson also voiced surprise that the boat ramp and parking lot were closed as early as 2 p.m. on Tuesday. Members of the public at the meeting agreed that restricting access that far in advance was excessive. The general sentiment shared was that Whaling Days has begun overstepping boundaries and that Old Town Silverdale businesses and residents are no longer being prioritized by the event's staff and committee.

Marvel suggested that the Port review county ordinances regarding noise levels to prevent similar issues in the future. Commissioner Scholfield responded that there is no specific decibel limit and that Silverdale does not have a sound ordinance in place, meaning the Port has no authority to regulate volume. Carla countered by noting that Whaling Days cannot be held without the Port's permission and approval, and that the Port therefore has more influence over the event than it has exercised. She urged the commissioners to take these concerns into account when negotiating details for next year's event and to consider the needs of Old Town Silverdale businesses and nearby residents.

Launches are being pulled every two weeks. Fuel is being stored in the sailing locker. A donated single is in the process of being refurbished; may be transferred to the Port by September.
