A RESOLUTION of the Commission of the Port of Silverdale, Kitsap County, Washington, approving the terms of the first amendment to the interlocal agreement creating the Washington Public Ports Insurance Authority; authorizing and directing E. C. FORD to execute the first amendment on behalf of the Port of Silverdale and deliver such agreement to the appropriate party.

WHEREAS, pursuant to Resolution No. 01-88, the Commissioners of the District approved the terms of an interlocal agreement providing for the creation of the Washington Public Ports Insurance Authority (the "Agreement") and authorized E. C. FORD to execute the Agreement on behalf of the District and to deliver it to the appropriate party; and

WHEREAS, the Board of Directors of the Authority have determined that certain terms of the Agreement should be amended to grant the Board of Directors greator flexibility in developing the Joint Protection Program to be provided by the Authority;

WHEREAS, the Commissioners have determined that the approval of such amendments is in the best interest of the District;

NOW, THEREFORE, be it resolved by the Commission of the Port of Silverdale, Kitsap County, WA as follows:

SECTION 1. The Commission hereby approves the terms of the first amendment to the interlocal agreement creating the Washington Public Ports Insurance Authority attached hereto as Exhibit A (the "First Amendment").

SECTION 2. The Commission hereby authorizes and directs E. C. FORD to execute the First Amendment on behalf of the District and to deliver such agreement to the offices of the Washington Public Ports Association.

FIRST AMENDMENT TO INTERLOCAL AGREEMENT CREATING THE WASHINGTON PUBLIC PORTS INSURANCE AUTHORITY

This first amendment to the interlocal agreement creating the Washington Public Ports Insurance Authority (the "First Amendment") is made and entered into in the state of Washington pursuant to the provisions of Chapter 39.34 RCW and Chapter 48.62 RCW by and among the Washington Port Districts listed in Exhibit A attached hereto (the "Members").

RECITALS

WHEREAS, the Members entered into an interlocal agreement pursuant to the provisions of Chapter 39.34 RCW and Chapter 48.62 RCW, which was effective May 16, 1988, to create the Washington Public Ports Insurance Authority (the "Authority"), a copy of which agreement is attached hereto as Exhibit B (the "Agreement"); and

WHEREAS, the Agreement requires the Board of Directors to establish the terms of the Joint Protection Program within 60 days after the effective date of the Agreement; and

WHEREAS, the Board of Directors of the Authority has determined that additional time will be required to complete the terms of the Joint Protection Program; and

WHEREAS, the parties to the Agreement wish to amend the terms of the Agreement to grant the Board additional flexibility with respect to the development of the Joint Protection Program.

AGREEMENT

Now, therefore, for and in consideration of the foregoing and the mutual benefits to be derived herefrom, the Members agree as follows:

1. The first two sentences of Section 4 of the Agreement shall be amended in their entirety to provide as follows:

Pursuant to Chapter 48.62 RCW and Chapter 39.34 RCW, the Members authorize and direct the Committee to incorporate the Authority within 60 days after the effective date of this Agreement as a nonprofit corporation pursuant to Chapter 24.03 RCW and articles of incorporation substantially in the form attached hereto as Exhibit B. The Committee shall serve as the initial board of directors until the first annual election of directors, which will be held no later than 75 days after the effective date of this Agreement.

2. The first two sentences of Section 6(a) of the Agreement shall be amended in their entirety to provide as follows:

On or before January 16, 1989, the Board of Directors shall adopt a resolution establishing the terms of the Joint Protection Program to be provided by the Authority during the initial three years of operation of the Joint Protection Program. A similiar resolution shall be adopted by the Board of Directors prior to the beginning of the fourth fiscal year of the Joint Protection Program and prior to the beginning of each fiscal year of the Joint Protection Program thereafter.

3. An additional sentence shall be added to the end of Section 6(a) which shall provide as follows:

Prior to the establishment of the Joint Protection Program the Board of Directors may establish and impose by resolution a reasonable periodic assessment to be paid by each Member to cover the Authority's operating expenses.

4. The initial sentence of Section 8.1 of the Agreement shall be amended in its entirety to provide as follows:

Within 75 days after the terms of the initial Joint Protection Program are established pursuant to Section 6(a) hereof, the estimated annual premium established by the Board of Directors pursuant to Section 6(a) hereof shall be presented to each Member by written notice.

5. Section 8.2 of the Agreement shall be amended in its entirety to provide as follows:

Effective Date of Joint Protection Program. The effective date of the Joint Protection Program shall be established by resolution of the Board of Directors.

6. Section 12 of the Agreement shall be amended in its entirety to provide as follows:

Cancellation. The Authority shall have the right to cancel any Member's participation in the Joint Protection Program and membership in the Authority upon the affirmative vote of at least three-fourths of the Board of Directors present at any regular or special meeting at which a quorum is present. Prior to the

Member so cancelled shall be given 15 days' written notice prior to the effective date of the cancellation. After the effective date of the Joint Protection Program, any Member so cancelled shall be given 180 days' written notice prior to the effective date of the cancellation.

- 7. The remaining terms of the Agreement are hereby expressly confirmed.
- 8. This First Amendment may be signed in counterpart or duplicate copies, and any signed counterpart or duplicate copy shall be equivalent to a signed original for all purposes.
- 9. The effective date of this First Amendment shall be retroactive to May 12, 1988, to coincide with the effective date of the Agreement.

IN WITNESS WHEREOF, the parties hereto have executed this first amendment to the interlocal agreement creating the Washington Public Ports Insurance Authority.

RESOLUTION NO. 88-2

A RESOLUTION SPECIFYING DATES FOR THE PREPARATION AND FILING OF THE ANNUAL PORT DISTRICT BUDGET AND TAX LEVY.

WHEREAS, R.C.W. 53.35.045 allows the Board of Commissioners of the District to specify the first Monday in December as the date for filing a certified copy of the Port District final budget with the county legislative body and to set dates for the budget process to conform with this filing date, and

WHEREAS, the Washington State Attorney General has ruled in AGO 1981 No. 11 that a port district may lawfully fix the amount of the district's property tax levy and file the same on the first Monday of December, now, therefore,

DE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE PORT OF SINVERDBLE as follows:

- 1. On or before the second Friday of November of each year the Port Commission shall prepare a preliminary budget of the Port District for the ensuing fiscal year showing the estimated expenditures and the anticipated available funds from which all expenditures are to be paid.
- 2. Following the preparation of the preliminary budget, the Port Commission shall publish notice of the availability of the preliminary budget and of the date, hour and place at which the Commission will meet for the purpose of fixing and adopting the final budget of the Port District for the ensuing year, which date

shall not be earlier than the second Friday of November nor later than the first Monday in December. Such notice shall be published in accordance with the requirements of R.C.W. 53.35.020.

- At the place and hour designated for the hearing on the final budget and at such times and places to which said hearing shall be continued, any person may present objections to the preliminary budget and following such hearing the Commission shall, by resolution, adopt a final budget which shall specify the amounts to be raised by taxation on the assessed valuation of the property in the Port District.
- On or before the first Monday in December the Commission shall file with the clerk of the county legislative authority, a certified copy of the Port District final budget which shall specify the amounts to be raised by taxation on the assessed valuation of the property in the Port District.

Alternate Port District Budget Dates

Dear Lew:

Attached you will find a suggested resolution which may be of use by the various port districts in specifying the later and alternate budget dates allowed by R.C.W. 53.35.045 and the opinion of the Attorney General rendered in AGO 1981 No. 11. This resolution is designed to be of a permanent nature which would apply to the budget process for future years.

It should be noted that the date chosen for filing the preliminary budget, the second Friday of November, is only a suggestion. The use of that date will allow approximately the same time spread between preparation of the preliminary budget and adoption of the final budget as has been provided by former practice. I doubt that any of the districts would want to shorten this time period, however, it would certainly be permissible to lengthen the time period by moving the date for filing the preliminary budget to an earlier time.

It should also be mentioned that in setting the date for the final budget hearing, it must be kept in mind that the notice of the public hearing has to be published once a week for two consecutive weeks, with the first publication to be not less than nine nor more than twenty days prior to the date of the hearing.

WHEREAS, an interlocal agreement (the "Agreement") providing for the creation of the Washington Public Ports Insurance Authority (the "Authority") has been submitted to the commissioners for their review and approval, and a copy of which is attached hereto as Exhibit A; and

WHEREAS, the Agreement provides for the creation of the Authority pursuant to Chapter 48.62 RCW and Chapter 39.34 RCW to provide a joint protection program for the benefit of port districts in the State of Washington organized and existing pursuant to Title 53 RCW; and

WHEREAS, the Commissioners have determined that it is in the best interest of the Port of Silverdale (the "District") to become a member of the Authority and to participate in the joint protection program provided by the Authority;

NOW, THEREFORE, be it resolved by the Commission of the Port of Silverdale, Kitsap, County, Washington, as follows:

SECTION 1. The Commission hereby approves the terms of the Agreement and authorizes and directs E. C. FORD to execute the Agreement on behalf of the District and to deliver such Agreement to the offices of the Washington Public Ports Association.

SECTION 2. As required by Article II, section 2, of the proposed bylaws of the Authority, the Commission hereby appoints E. C. FORD as the District's representative to the Authority, who shall be authorized to exercise the District's voting rights in the corporation to be created pursuant to the terms of the Agreement and to act on behalf of the District with respect to all matters pertaining to the Authority.
