#### RE: INCREASING PROPERTY TAX REVENUE BY 1%

WHEREAS, the Port Commission of the Port of Silverdale has properly given notice of the public hearing held November 20, 2003 to consider the Port District's current expense budget for the 2004 calendar year, pursuant to RCW 84.55.120; and

WHEREAS, the Port Commission, after the public hearing and after duly considering all relevant evidence and testimony presented, has determined that the Port District requires an increase in property tax revenue from the previous year up to the maximum amount allowed under Chapter 88.55 RCW, including the use of a limit factor of 101% applied to the prior maximum tax levy for tax year 2003, in order to discharge the expected expenses and obligations of the Port District and in the best interest of the Port District; and

WHEREAS, the population of the Port District is over 10,000;

**NOW, THEREFORE, BE IT RESOLVED** by the Port Commission of the Port of Silverdale that an increase in the regular property tax levy, in addition to any amount resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, is hereby authorized for the 2004 levy in the amount of \$4,516.00, which applies the applicable statutory limit factor.

### REQUESTING KITSAP COUNTY SHERIFF PARKING ENFORCEMENT

WHEREAS, the Port of Silverdale owns property along the waterfront in Silverdale which is primarily intended and required to be used for parking by users of the Port's recreational waterfront facilities; and

WHEREAS, one area of the Port's property is specifically set aside for parking of vehicles with boat trailers attached, and is so marked and signed, but users of Kitsap County's Silverale Waterfront Park adjacent to the Port's parking facilites have been regularly and frequently paking on Port property, particularly in the area reserved for boat trailer parking in direct disregard of plainly posted signs and markings; and

WHEREAS, the Kitsap County Sheriff's Office will not enforce the parking restrictions on the Port property without a resolution by the Port requesting such enforcement;

NOW, THEREFORE, IT IS HEREBY RESOLVED, by the Port Commission of the Port of Silverdale that the Kitsap County Sheriff's Office is authorized and requested to assist in enforcing parking restrictions on the Port's waterfront property in the spaces identified as parking for vehicles with boat trailers only, and to issue parking tickets for vehicles improperly parked on Port property and/or arrange for such vehicles to be towed away at the owners's risk and expense.

#### NOTICE OF SPECIAL MEETINGS WITH OTHER KITSAP COUNTY PORTS

WHEREAS, it is beneficial for the Commissioners for the Port of Silverdale to share at appropriate intervals with commissioners from other port districts in Kitsap County matters of mutual interest relating to the well-being and good operation of the respective port districts in Kitsap County; and

WHEREAS, a working relationship has been established among the port districts in Kitsap County for their mutual benefit, initiated by the ports after the Kitsap County Board of Commissioners convened a meeting of all local governments to promote dialogs, so that we can perform more effective services for our constituents; and

WHEREAS, the Open Public Meetings Act of 1971 (Chapter 42.30 RCW) requires that all actions of the Port of Silverdale, which includes discussions, be taken in open meetings for which prior notice is given, and discussions of matters of interest to the Port of Silverdale at a meeting with other port districts might be construed as such an "action" within the meaning of the Open Public Meetings Act;

NOW, THEREFORE, BE IT RESOLVED, by the Port Commission of the Port of Silverdale that periodic meetings jointly by two or more of the Commissioners of the Port of Silverdale held with other port district commissioners within Kitsap County should be designated as "special meetings" of the Port Commission of the Port of Silverdale under RCW 42.30.080 to discuss matters of mutual interest to the participants; and

BE IT FURTHER RESOLVED, that such special meetings of the Port Commission of the Port of Silverdale together with other port district commissioners in Kitsap County shall be held at 7:00 pm on the fourth Monday in January, and the third Mondays in April, July and October of each year, at the Port of Silverdale offices, or at such other time and place as may be determined by consensus of the group attending any such "all ports" meeting.
