ACCEPTING BOATS AND EQUIPMENT FOR SAILING AND ROWING PROGRAM

1. WHEREAS:

- 1.1. The Port of Silverdale (Port) owns fee title and leasehold interest in waterfront property in Silverdale, Washington, with a public pier and floats for motorized boats, a float for non-motorized boats, and an upland boat storage area for non-motorized small watercraft;
- 1.2. Since 2005 the Kitsap Sailing and Rowing Foundation (KSRF) has used a portion of the upland boat storage area and the non-motorized boat float for the KSRF managed Recreational Sailing and Rowing Program of the Kitsap County Department of Parks and Recreation;
- 1.3. Pursuant to Port Resolution 2013-05, adopted on November 21, 2013, as authorized by RCW 53.08.260, RCW 39.33.010 and RCW 53.08.110, the Port assumed sponsorship of the Recreational Sailing and Rowing Program operated and managed by KSRF, and accepted transfer of ownership from Kitsap County of boats and equipment used in the Recreational Sailing and Rowing Program and identified in an addendum attached to Port Resolution 2013-05;
- 1.4. Possession and title to the boats and equipment listed in the addendum attached to Port Resolution 2013-05, as well as other boats and equipment, have been transferred to the Port;
- 1.5. Additional boats and items of equipment, listed in the addendum attached to this resolution, have been offered to the Port for use in the Recreational Sailing and Rowing Program.
- 2. NOW, THEREFORE, it is hereby RESOLVED, by the Port Commission of the Port of Silverdale:
 - 2.1. The Port confirms the acceptance of possession, ownership and title to the boats and equipment already transferred to the Port since adoption of Port Resolution 2013-05; and
 - 2.2. The Port hereby accepts possession, ownership, and title to the boats and equipment listed in the addendum attached to this resolution for use in the Recreational Sailing and Rowing Program operated and managed by KSRF.
