WHEREAS, the Silverdale Port Commissioner's, during a regularly scheduled meeting, reviewed the Port rules and determined an update was necessary; AND

NOW, THEREFORE, BE IT RESOLVED, by the Port Commission of the Silverdale Port District that the attached "RULES FOR USE OF PORT PROPERTY" are adopted by the Silverdale Port District at a regular open public meeting thereof held on August 17, 2017.

RULES FOR USE OF PORT PROPERTY

A. GENERAL RULES

- 1. COMMERCIAL ACTIVITY ALLOWED ONLY WITH PORT PERMISSION*
- 2. NO OUTDOOR FIRES
- 3. NO ALCOHOL CONSUMPTION
- 4. PICK UP YOUR PET'S WASTE AND DISPOSE IN TRASH RECEPTACLE
- 5. ONLY GARBAGE FROM PORT PROPERTY OR BOATS GOES IN PORT TRASH RECEPTACLES, NOT GARBAGE FROM ELSEWHERE
- 6. DON'T FEED WILD ANIMALS OR BIRDS BIRD DROPPINGS ARE A HEALTH HAZARD
- 7. FIVE MILES PER HOUR MAXIMUM VEHICLE SPEED
- 8. NO PUBLIC NOISE DISTURBANCES (KITSAP COUNTY CODE 10.28.145)

B. VEHICLE PARKING AREAS

- 1. IN VEHICLE-ONLY PARKING LOT FOUR HOUR PARKING LIMIT
- 2. IN BOAT TRAILER PARKING AREAS
 - a. PARKED VEHICLES MUST BE ATTACHED TO A BOAT TRAILER
 b. DETACHED BOAT TRAILER PARKING IS ALLOWED
 c. CLOSED DUSK TO DAWN EXCEPT FOR BOATERS
- 3. IN ALL PARKING AREAS –
 a. PARK ONLY IN MARKED PARKING STALLS
 b. NO OVERNIGHT PARKING WITHOUT PORT PERMISSION*

C. PIER, FLOATS, AND MOORAGE AREAS

- 1. CLOSED DUSK TO DAWN EXCEPT FOR BOATERS
- 2. NO SWIMMING IN MOORAGE AREA
- 3. NO DIVING OR JUMPING FROM PIER OR FLOATS
- 4. NO WATERSKIING OR BOAT WAKE WITHIN 500 FEET OF MOORAGE AREA
- 5. CHILDREN UNDER AGE 14 ON PIER OR FLOATS MUST WEAR PERSONAL FLOTATION DEVICES OR BE ACCOMPANIED BY ADULT
- 6. NO SMOKING ON PIER OR FLOATS
- 7. NO OPEN FLAME OR BARBEQUES ON PIER OR FLOATS
- 8. NO RECREATIONAL USE OF WHEELED VEHICLES ON PIER OR FLOATS
